Course objective

The course content and the teaching aims to provide an insight into the role of research communication for research and for society, as well as the role and responsibility of the researcher in a polarized world.

Course content

- Collaboration with the wider society according to the Higher Education Ordinance
- Research communication in a polarised world.
- The researcher's obligation of researching and react to societal challenges.
- Researchers' commissions for civil society, municipalities, regions, authorities, and companies.
- Media's role and mode of operation as well as considerations in media contacts.
- Reasons for and consequences of when research becomes political.



The content includes, partly:

- Assignments for municipalities, regions, public agencies and companies
- The functions and logics of media as well as considerations when communicating with journalists
- Reasons for, and consequences of, research becoming political

Intended learning outcomes

After completing the course, the doctoral student should be able to:

 show ability to identify and analyse possible roles for researchers in research collaborations with actors in civil society, business, and the public sector to meet various societal challenges.

Judgement and approach

Teaching formats

Lectures and seminars.

Examination

INL: Written submission task. Written submission concerning the doctoral student's own research area and how research can contribute to society, 1.5 credits

OBL: Active participation in the course's three seminars, 1 credit



Grade

Tests that are included in the course are assessed according to a two-point grading scale with the grades fail or pass (G and U).

Grades must be decided by a teacher specially appointed by the university.

Anyone who has not been approved in the regular exam must be given the opportunity to retake the exam.

Requirements

To participate in the course and course examinations, the applicant must be admitted to graduate level education at Mälardalen University.

Selection criteria

Doctoral students accepted at other universities in, and outside Sweden can be granted access to the course subject due to availability. This also applies to teachers with a doctorate at Mälardalen University. Selection of applicants is made in accordance with the ranking below.

- 3. Admitted doctoral students at other universities outside Sweden
- 4. Teachers holding a doctorate at Mälardalen University
